**<u>Purpose:</u>** To Examine GOD's Laws - Enjoy nature, and a magnificent facility.

<u>Who:</u> All Cub Scouts, Boy Scouts, Venture scouts, Explorers, and Sea Scouts <u>in grades 1 through 12</u>, of the Venice Dioceses and/or Southwest Florida Council, parents, and siblings. Stroller and wheelchair accessible.

<u>Preparation:</u> Wear appropriate shoes and clothes (Class A –field uniform), carry sufficient water to stay hydrated, wear sun block and insect repellent. Practice Leave no Trace and the Buddy System. A LIGHT LUNCH will be provided. Follow current Covid 19 guidelines concerning community events.

<u>Program:</u> Participants will "Check in" beginning at 8:00 a.m. at the Desk and assigned a starting point along the hiking trail. Several stops are designated to examine a law. Law discussions will last approximately 10 minutes and travel time between stops of 5 minutes. (So, a law program starts on each quarter hour.) After all stops have been visited, we will gather at the Chapel area for a Prayer Service and the distribution of patches.

After the program, participants may visit other areas of the facility, and enjoy a light lunch.

## **DIRECTIONS TO OLPH**

• Take 1-75 to Exit 193

Jacaranda Blvd.

- from the South, turn right;
- from the North, turn left.
- Proceed 0.8 mile to the 4-way stop at Border Road; turn right.
- Proceed 2.5 miles to the stop sign at South Moon Drive; turn right.
- Proceed to the stop sign, and take the **left fork** to continue on South Moon Drive.
- Continue on South Moon Drive, crossing over 1-75.

  Then **enter the OLPH parking lot** where South Moon Drive becomes Forbes Trail.
