Payment Information

Payment information applies to youth and adult contingent members of the 2017 National Jamboree from the Greater Yosemite Council.

Jamboree participants are expected to make good faith payments toward the cost of the Jamboree experience. Payments are made directly to the Greater Yosemite Council office in Modesto. Please make all checks out to “Boy Scouts of America” with “2017 National Jamboree” in the memo line. The total cost of the trip is \$2500. Jamboree scholarships are available from the National office of the Boy Scouts of America. Online applications are available at summit.scouting.org. Scholarship decisions are being made on the basis of need and they are being made in a timely manner so that all families will know in a timely manner if they will receive a scholarship.

It is important to note that scholarship funds apply only to the initial \$975 registration fee charged by the National Office of the BSA for the cost of the jamboree itself. All other expenses - air & ground transportation, meals, tour, and other contingent expenses - must be paid out of the remaining jamboree fees. And, they must be paid on time. That is why it is important for all participants to keep up with the Jamboree payment schedule listed below.

Refund Policy.

1. The initial \$250 deposit is neither refundable nor transferable.
2. All Jamboree payments are non refundable. The only exception is if the person requesting a refund can find a replacement. Then, and only then, all fees, paid to date, except the \$250 deposit will be refunded.
3. Deposit fees paid by alternates not selected as active participants will be refunded in full.
4. There will be no refunds for any reason following the jamboree.
 - a. All refunds must be requested in writing and include the following statements: A full name of the jamboree contingent member.
 - b. A statement requesting withdrawal from the jamboree contingent.
 - c. A statement requesting a refund.
 - d.** A signature of parent or legal guardian if the request is being made on behalf of a minor
